Introduction

#### 1. Introduction

August 2023 has marked the third full month of the Anti-Homosexuality Act 2023 (AHA) being in force, and in this month, both the state and the citizens have continued to zealously enforce the AHA in their different capacities, with arrests of real or suspected LGBTQ persons continuing, as well as cases of violence and evictions from rented accommodation. This is a report of the nature of cases affecting LGBTQ persons handled by the Legal Aid Clinic at HRAPF during the month of August 2023.

This report builds on previous reports in this series, which have documented violence and violations of the rights of LGBTQ persons during the run up to the passing of the AHA, the first 21 days of implementation of the AHA, and the first and second months respectively. The report also documents the total number of cases since the AHA came into force, and makes comparisons between August and the first two months, as well as the same period June to August 2023.

### 2. Methodology

This report contains data on cases handled by the HRAPF Legal Aid Clinic during the month of August 2023 only. The data for the report has been drawn from cases received across the HRAPF legal aid network during the month, including the network of 132 community paralegals, the main legal aid clinic in Kampala, the specialised legal aid desks as well as the regional legal aid centres hosted by partners across the country.

The data was collected through a review of case files, from which quantitative data as to the numbers and natures of cases and cases of violence and violations was ascertained. The cases in which violence and other violations appeared on the face of it to have occurred where then subjected to qualitative review to confirm the basis of the violence or violations in order to ensure that only cases in which such violence was on the basis of the sexuality of the victim were included in the report.

Like previous reports in this series, it is important to note that this report contains only those cases which have been handled and verified by HRAPF and does not cover cases that may have been reported to other legal providers, or not reported at all. The report therefore does not present a complete picture of the situation of LGBTQ people across the country in August, and is thus limited in this regard. However, the report does capture cases reported from across the country through HRAPF's vast network, and therefore presents a fairly representative picture of SOGIE-based violence in light of the enforcement of the AHA 2023.

# 3. Nature and number of cases reported

In the month of August 2023, HRAPF handled a total of 71 cases across the legal aid network, a reduction from 84 in July 2023. Out of the 71 cases handled, 47 involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing

66.2% of all the cases handled during the month. Out of these, 22 were cases of eviction from rented properties, 19 were cases of violence and threats of violence and 6 were arrests for sexuality-related reasons. These actions affected a total of 59 individuals. This section of the report provides detailed data on these cases.

### 3.1. Evictions from rented property

In August 2023, a total of 22 cases of eviction involving 26 persons were reported, and in each of these cases the eviction was whole or primarily based on the fact that the tenant was a suspected homosexual. The evictions were primarily spearheaded by the property owners, many of whom cited the fear of being in conflict with the law as the basis for the eviction. Landlords carried out evictions of their tenants in 10 cases, followed by family members of LGBTQ persons in 5 cases, followed by neighbours in 2 cases and Local Council I (LC I) (village) officials in 1 case, and property manager in 1 case. In three cases, evictions were by multiple actors - by both the landlord and the neighbours in one case; by the landlord and LC I officials in another; and by the landlord, LC I officials and police authorities in yet another case.

The majority of these evictions took place within the Kampala metropolitan areas, that is, 10 cases within Kampala district itself, and 5 cases from Wakiso district. The other cases were all in Eastern Uganda, 4 in Mbale district, 2 in Tororo and 1 in Bulambuli, representing a definite spike in this category of cases in the eastern region.

# 3.2. Cases of violence

In August 2023, there were 17 cases reported involving violence and threats of violence against 20 persons (a reduction from 21 cases reported in July 2023). Of these, 12 were cases of actual violence against persons on the basis of their presumed sexuality, while 5 were threats of violence.

# i) Cases of actual violence on the basis of sexual orientation/gender identity

There were 13 cases of actual violence against persons on the basis of their real or presumed SOGIE in August 2023 affecting 14 persons, with the majority of them being physical assaults (9 cases). There were also cases of extortion (1); verbal abuse (1); sexual harassment (1); and 'revenge' pornography (1).

The violence was perpetrated entirely by non-state actors, with 6 assaults being orchestrated by unknown strangers and 1 case each by family members, friends, neighbours, intimate partners, bodaboda riders and 1 by a landlord's child. In one case, a family ganged up with the neighbours of two people to form a mob and beat them up. The majority of these cases were reported from within the Kampala metropolitan area (4 cases from Kampala and 5 from Wakiso) while the rest were reported in the Eastern region (2 each from Mbale and Bulambuli).

# ii) Cases involving threats of violence based on sexual orientation and/or gender identity

During the month of August, there were 6 cases involving threats of violence against persons on the basis of their real or presumed SOGIE from Mbale (3), Isingiro (1), Kampala (1) and Wakiso (1). These cases affected a total of 8 individuals and the threats included 3 threats of physical violence, 2 threats of arrest, and 1 threat of sexual violence. They were perpetrated by neighbours in 2 cases, family in 2 cases, neighbours and the LC I authorities in 1 and neighbours and police authorities in 1.

# 3.3. Cases of arrest

There were 6 cases of arrests of persons on the basis of their sexuality in the month of August 2023, of which 2 were taken to court while 3 were resolved at the police level. In 3 of these cases, the individuals involved were charged with homosexuality (1 was taken to court); 1 was charged with aggravated homosexuality and taken to court and in 2 cases the victims were not charged at all. These arrests affected a total of 11 individuals, 6 of whom were subjected to forced anal examinations during detention. The arrests happened in Wakiso (1); Soroti (1); Sironko (1); Kyegegwa (1) and Kampala (2).

**NB**: The cases of arrests reported here exclude cases that HRAPF's legal aid clinic does not handle, particularly those were the person is accused of having sexual relations with a person below 18 years of age, and cases involving persons who have been banned from receiving legal aid services from HRAPF due to violations of the HRAPF Legal Aid Policy.

### 4. Comparison with July 2023

The data indicates that there is active and continuing enforcement of the AHA 2023, and that in the month of August 2023, both the state and private citizens continued to enforce the law as they interpret its strictures. This holds steady since 31st May 2023, when the law first came into force, and is unlikely to stop as long as the law continues in force.

However, there has been a reduction in the number of cases reported overall as well as the number of cases involving actions that deliberately targeted persons for negative treatment on the basis of their real or presumed SOGIE. In July 2023, a total of 84 cases involving LGBTQ persons were reported across the network as compared to 71 in August, a reduction of 15.5%. In terms of the cases that specifically targeted individuals on the basis of their SOGIE, there was also a reduction from 53 cases affecting 67 people in July 2023 to 47 cases affecting 59 people in August 2023. However, the percentage of the total number of cases per month in which people were deliberately targeted because of their real or presumed SOGIE increased from 63.1% in July to 66.2% in August 2023.

In both months, the biggest number of cases were evictions, with 26 cases of evictions affecting 33 people reported in July 2023, although this number went down to 22 cases affecting 26 people in August 2023. This was followed by cases of violence against persons in both months, with 21 cases reported in July, affecting 24 persons, compared to 19 cases reported in August, affecting 22 persons. Cases of arrests on sexuality related charges held steady at 6 in July and 6 in August, although the arrests in August affected a slightly higher number of persons, that is, 11 people a compared to 10 in July.

In all the cases involving real or threatened violence, there has remained a continuing reluctance by the affected people to report the matters to the authorities out of fear of further victimization, which has in fact happened in at least one case (where 5 people were arrested by the police and charged with homosexuality after they complained about some individuals brutally assaulting one of their colleagues for allegedly hitting on them). While the majority of the violence and violations are being perpetrated by non-state actors therefore, there is still very little effort by the state in the way of redressing these violations and violence.

The trends in arrests are also noteworthy as they indicate a formal acknowledgment, and therefore deliberate enforcement, of the AHA 2023. During the month of August in particular, one case drew a significant amount of attention as the first case in which a person was charged with aggravated homosexuality for sexual activity between adults. The basis for the charge was the fact that one of the persons involved had a physical disability limiting their mobility, although latter accounts of the incident indicate that the person who was arrested and charged was a homeless person with a perceived mental disability. Nevertheless, in the wake of so much media attention, the office of the Director of Public Prosecutions issued a circular cautioning state attorneys against preferring charges under the AHA, a formal recognition again of the enforcement of the AHA through the police, courts and DPP's office, and called for all such files to be reviewed at the head office. This may result in some positive developments for individuals who have been charged under the AHA, particularly those awaiting trial, although how far this impact may stretch remains to be seen. However, the particular individual remains in jail on remand.

Another worrying development is nonconsensual anal examinations. Six were recorded in the month of August and yet there was none in July.

#### 5. Comparison with the period from 1st August 2022 to 31st August 2022

In August 2022, a total of 45 cases were handled involving LGBTQ persons, of which 13 cases involved actions that directly targeted persons on the basis of their real or presumed SOGIE. The actions in these 13 cases affected a total of 13 people, and included 9 cases of real or threatened violence, 3 evictions and 1 arrest.

It is quite clear that there has been a significant increase in these cases in August 2023, as discussed above: in August 2023, the HRAPF legal aid programme handled 71 cases, of which 47 involved actions that deliberately targeted persons on the basis of their real or presumed SOGIE. Between August 2022 and August 2023, there has been an increase of 72.3% in SOGIE motivated abuse and violence. The cases of real or threatened violence have also increased greatly from 9 in August 2022 to 19 in August 2023; evictions have increased from 3 in August 2022 to 22 in August 2022 and arrests have increased from 1 in August 2022 to 6 in August 2023.

The difference in these figures is clearly attributable to the existence of the AHA, although it should be noted that, in August 2022, there was also a slight increase in SOGIE motivated abuse and violence following the story of a one Mukisa Elisha alleging recruitment into homosexuality and abuse, which sparked extensive public debate about homosexuality in Uganda (and quite probably marked a turning point in the journey towards the Anti Homosexuality Act, 2023).

### 6. The first three months of the AHA 2023 in Uganda

In the first three months of the AHA 2023, a total of 220 cases involving LGBTQ persons have been handled across the HRAPF legal aid network, of which 146 (66.4%) targeted LGBTIQ people on the basis of their sexuality, affecting a total of 176 persons. The breakdown of cases so far is as follows:

In comparison with the same three-month period in 2022, a total of 107 LGBTIQ cases were handled in that period, of which 34 cases (31.8%) contained actions that deliberately targeted LGBTIQ persons for detrimental treatment. This translates to an increase of 112 cases or a percentage increase of 329.4%.

#### 7. Conclusion

The trends as discussed above indicate a clear connection between the enforcement of the AHA 2023 and the incidence of violence and violations against KGBTQ people. It is worth noting that, while cases of violence against persons on the basis of their real or presumed SOGIE have been steadily decreasing over the past three months (albeit with only minor variations), and cases of evictions appear to also be reducing from July to August, cases of arrest, which is the real enforcement by the state, have continued to increase steadily from 4 in June to 6 in July and August, indicating quite clearly that the AHA's enforcement is going strong, as is its impact on the lives of LGBTQ persons in Uganda. Anal examinations on arrested persons are the latest worrying development that was not there before.
